### TERMS AND CONDITIONS FOR CARD LOCK BULK WATER STATIONS

1. An initial minimum \$10.00 purchase will provide the customer with a reusable, refillable cash card. The card may be used to purchase water from any of the available card lock bulk water stations provided throughout the service area and may be reloaded at the El Dorado Irrigation District (EID) main office. Unused card values are not refundable or transferable. Values of lost cards may only be transferred to a replacement card at the discretion of EID.
2. Subject to the terms and conditions of this permit and all other applicable EID rules and regulations, permittee is hereby granted revocable, personal permission to use water from EID's card lock bulk water stations.
3. EID reserves the right in its sole discretion to accept or reject any application for a permit for use of temporary water and/or to suspend, revoke or modify any such permit at any time after issuance.
4. Permittee shall, to the fullest extent permitted by law, indemnify, defend and hold harmless EID, and its officials, employees, agents and representatives, from and against any and all claims, damages, loss and/or liabilities for injury to any person(s) (including death) or damage to any property (real or personal) arising out of or related to, directly or indirectly, any activity of the permittee under this permit, including without limitation any damage, loss or theft of any EID hardware or connection used hereunder.
5. Permittee shall notify EID of any missing, broken, damaged or otherwise malfunctioning hardware immediately upon discovery. Broken, damaged or otherwise malfunctioning hardware shall not be used to take any water.
6. Permittee shall comply with all terms and conditions of this permit and all applicable EID rules and regulations at all times hereunder, including without limitation all fees and charges for issuance of this permit and use of water hereunder. 7. Permittee shall notify EID if a card is lost or stolen so that EID may deactivate the card.
8. Current bulk water charge for 1,000 gallons of drinking water is \$5.00.
