## **REQUIRED TERMS AND CONDITIONS**

**LIMITED PERMISSION TO USE EL DORADO IRRIGATION DISTRICT (EID) RECREATION AREAS.** I, applicant, understand and agree that, if granted, the Annual Day Use Permit only confers the person named on the front of this application with limited, revocable, nontransferable permission to use EID Recreation Areas during the term of the Annual Day Use Permit in accordance with all existing and future rules, regulations, availability and conditions of EID governing said use as well as all applicable federal, state and local laws. I understand and agree that said permission to use EID Recreation Areas under the Annual Day Use Permit may be revoked by EID at any time should I fail to comply with any rules, regulations or conditions of EID or federal, state or local laws applicable to my use of EID Recreation Areas.

**RELEASE AND INDEMNITY.** In exchange for permission to use EID Recreation Areas under the Annual Day Use Permit, if granted, and to the greatest extent permitted by law, in submitting this Application I hereby agree to release, indemnify, defend and hold harmless EID, its officials, officers, employees, and agents from and against any and all claims, loss, damages, costs, expenses, liabilities or obligations (collectively "Claims") arising out of or in any way connected with or alleged to be connected with this Application, the Annual Day Use Permit or my, or my guests, use of EID Recreation Areas, including without limitation, Claims for loss or damage to any property or for death or injury to any person or persons, however occurring, other than those caused solely by the willful or grossly negligent acts or omissions of EID. I hereby waive the provision of California Civil Code section 1542, which provides, "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

**LIMITATION OF LIABILITY.** In exchange for permission to use EID Recreation Areas under the Annual Day Use Permit, if granted, I hereby expressly understand and agree that, to the extent not prohibited by law, in no event shall EID, its officials, officers, employees or agents be liable for any claimed or actual damages or losses, including, without limitation, loss of revenue or profit or for direct, indirect, consequential, special, incidental or punitive damages, however caused regardless of the theory of liability, arising out of or related to this Application, the Annual Day Use Permit or my, or my guests, use of EID Recreation Areas, even if EID has been advised of the possibility of such damages.
